The exterior of the villa is constructed from concrete. The basement features a fitness center, saunas, and a wine cellar. The ground floor extends down the rock face. The main bedroom on the upper floor comes with a terrace and a pool that fully opens up to a spectacular view. In the garden, you'll find a mini spa and an outdoor pool. The villa is 3 kilometers away from Opatija and 700 meters (as the crow flies) from the sea. Opatija is approximately 14 kilometers from Rijeka and 1.7 kilometers from the Ičići beach. This coastal town is renowned for its historical charm and a unique ambiance that is truly unparalleled in Croatia.

Opatija is a true jewel on the Adriatic and one of the most renowned tourist destinations in the Kvarner Bay and the entire Croatia. One of the unique and perhaps the most beautiful attractions of Opatija is the Lungomare, a picturesque seaside promenade, where numerous beautiful beaches invite you to sunbathe, swim, and relax.

Villa is situated on a mild slope with lovely views of Cres to the South and Rijeka to the East. The first impression was that it is imperative to preserve as many trees as possible to hide the villa from the other villas and from the street to ensure complete privacy.

The second impression was that two big advantages of the plot need to be accentuated; the beautiful structure of rocks and the stunning views. The contemporary design of villa is in a perfect harmony with surrounding nature, as if it were there for ages.
