

Villa belongs to 1962, completely rebuilt in 2008 and then modernized in 2014...

Villa has three levels and panoramic sea view.

Lower floor has an independent entrance and offers 2 bedrooms, bathroom plus household room (laundry). and fitness studio (gym).

Middle floor offers studio, dining room, salon, kitchen, office with separate entrance, guest wc. Spiral staircase to the 3rd floor. There is a large balcony on the 2d floorn and also independent indoor garden of 60 m2, with panoramic glass walls.

Upper floor has a hall, 3 bedrooms, 2 of them with large balconies, 2 bathrooms with jacuzzi, shower, bidet, toilet. Exit to the open terrace of 50 m2 with marvellous sea views.

The villa is fully furnished and equipped with appliances and electronics.

Land area of 651 m2 is fenced with natural stone in combination with a wrought iron fence and laurel higher than 2 metres which guarantees complete privacy and perfect isolation.

Villa benefits:

- Well-groomed lawn combined with stone tiles.
- Trees palm trees, grapes, figs, cypress, laurel.
- Automatic irrigation system.
- Natural stone grill with mechanical baking rack.
- Swimming pool with sea water 75 m³ (9.5 * 4.5 * 1.8).
- Automatic filtration system water pump, filter, etc.
- Automatic iron doors on remote control
- Central heating (Boiler 2000 liters of diesel)
- Underfloor heating
- Seven air conditioners
- Car garage with automatic garage door.
- Auxiliary garage
- Boiler room and storage.

The villa is completely ready for life.


